BY THE ORDER OF THE CITY OF BLAND

WHEREAS, Section 304.013 (4) RSMo, provides that the governing body of a city may issue special permits to licensed drivers for special uses of all-terrain vehicles on city streets within the CITY OF BLAND: and

WHEREAS, it appears to the CITY OF BLAND that a need exists for property/residents/visitors of the CITY OF BLAND for such permits;

NOW, THEREFORE, it is the ORDER OF THE CITY OF BLAND as follows:

1. That persons over the age of eighteen (18), and duly licensed by the State of Missouri or any other state to operate a motor vehicle may, upon proper application to the CITY OF BLAND, be issued a permit to operate an all-terrain vehicle on city streets with in the CITY OF BLAND, MISSOURI subject to the requirements set below.
2. All requirements set out in Section 304.013, RSMo, are incorporated herein by this reference, as if full forth herein at length.
3. An operator must have a valid driver's license and any passenger under the age of eighteen (18), must wear an approved (DOT) motorcycle helmet.
4. No all-terrain vehicles shall travel over 20 mph on the CITY OF BLAND streets, and they shall obey all traffic laws.
5. When operated on the BLAND CITY STREETS, an all-terrain vehicle shall have a bicycle safety flag, which extends not less than seven feet above the ground, attached to the rear of the vehicle. The bicycle safety flag shall be triangular in shape with an area of not less than thirty square inches and shall be day-glow in color. The all-terrain vehicle must have working headlamps and tail lamps that shall be always left on while operating on the CITY OF BLAND streets.
6. The all-terrain vehicle must be registered with the STATE OF MISSOURI, and/or have a manufacture certification of origin.
7. The applicant must provide to the CITY OF BLAND the make, model number, serial number, and year of the all-terrain vehicle when making application. The permit shall only be valid for the vehicle listed on the permit. The applicant must also show the CITY OF BLAND proof of liability insurance and must maintain such insurance while operating the all-terrain vehicle on the CITY OF BLAND streets.
8. No operator of an all-terrain vehicle on the CITY OF BLAND streets under this Order shall be permitted to carry passengers, unless the all-terrain vehicle is equipped to do so.

9. The applicant shall pay to the CITY OF BLAND, at the time of application, a fee of fifteen dollars (\$15.00) for a period of a calendar year. All permits expire at the end of each calendar year.
10. All permits will be valid from January 1 until December 31 and shall be renewed yearly.
11. The permits shall be displayed on the left (driver side) front fender in a manner that is visible to law enforcement.
12. Anyone found violating the requirements shall have their permit revoked for a period of one year (1 year), and/or may be subject to any applicable criminal charges.
13. Proof of paid personal property tax must be provided at the time of application (per the CITY OF BLAND).
